## Learning Outcomes for the Professional Course

After participating in this course, speech-language pathologists will be able to:

- Describe the DIR Model and the developmental levels
- Discuss how the DIR Model and Floortime support language assessment and intervention
- Determine a child's functional developmental level and compare that level to age-expected level
- Analyze the impact of interpersonal relationships and caregiver affect on adaptive language development
- Identify the ways a child's behavior, affect, and developmental patterns influence communication
- Assess the effects of family patterns, stresses and conflicts, as well as constitutional and maturational patterns on language development and use
- Plan developmental language intervention strategies for children with a wide variety of diagnoses, including Autism Spectrum Disorders, ADHD/ADD, learning disabilities, etc.
